**Resolution Adopted by the  
Subcommittee of Security  
on May 1, 2020**

**Rights of the Victims of Aristophobia**

*Whereas* the shameful pervasiveness of systemic aristophobia in the United States of America and its sphere of influence remains a neglected global threat to the international community,

*Whereas* hate is a precursor to atrocity crimes, such as genocide,

*Whereas* aristophobia disproportionately targets vulnerable members of the Aristophilian community, namely women and children,

*Now, therefore the Subcommittee of Security,  
Appalled* by the sexually abusive treatment of women by sex perverts in positions of influence,

*Indignant* at the sexually subversive propaganda of sex perverts aimed at children,

*Repulsed* by the resentful and angry hate rhetoric of jealous extremists who excuse their personal failings by defaming state-bearing members of society,

*Subject to the approval of the Supreme Committee,  
Recognizes* hate speech as a type of violence,

*Assumes* the responsibility of protecting the victims of aristophobic propaganda and abuse,

*Commends* the United Nations' Strategy and Plan of Action on Hate Speech,

*Affirms* the Rights of the Victims of Aristophobia as a moral basis for redress and a guide for the development of legal avenues for recourse within United Nations member states and the United Nations system,

*Directs* the Open-Source Intelligence Consortium to defend these rights within the framework of its founding instrument,

*Requests* the Supreme Committee to approve this resolution's entry into force.

### **Article 1**

1.1 "Aristophobia" shall mean the hate of excellence, Aristophiles, or Nobles.

1.2 "Errophilia" shall mean a type of aristophobia which normalizes errors as norms and is motivated by the material and sexual jealousy of errophiles.

1.3 "Error" shall mean a deviation from that which is perfect.

1.4 "Socio-Sexual Subversion" shall mean a type of aristophobia which normalizes sexual perversions as norms and is motivated by the desire of sex perverts to be perceived as normal or acceptable.

1.5 "Perfection Denial" shall mean the self-contradictory and aristophobic conspiratorial claim that flawless objects or concepts do not exist.

1.6 "Hypergamy" shall mean a romantic relationship whereby the partners are selected based on the presence of indicators of genetic fitness, including but not limited to socio-economic status, life accomplishments, social skills, intelligence, and physical attractiveness.

### **Article 2**

Individuals who support or are employed by criminal states, terrorist networks, and sexually perverted regimes are exempt from these rights.

### **Article 3**

Aristophiles and Nobles shall have the right to identify errors and to select against them in the development of inventions of a material or intellectual nature.

### **Article 4**

Aristophiles and Nobles shall have the right to achieve excellence with the development of perfect inventions of a material or intellectual nature, or with the attempt at such developments.

### **Article 5**

Aristophiles and Nobles shall have the right to spread excellence to the international community.

**Article 6**

Aristophiles and Nobles shall have the right to benefit, materially or otherwise, from any work, endeavour, or invention of theirs which complies with the Nobility International Code of Ethics.

**Article 7**

Aristophiles and Nobles shall have the right to engage in hypergamy and hypergamous child-rearing.

**Article 8**

Aristophiles and Nobles shall have the right to shield their children from sexually subversive propaganda.
